- Meeting with CYPES 06 November
  - Explained that the Policy might be amended to extend the period
  - o 5 Bespoke items

- Meeting CYPES 23 November
  - Confirmed that the end date would be extended by three years to Sept 2026 (only 2 years in reality)
  - Five Bespoke items (under review)
  - Schools would not be allowed to run school shops or buy back any of their uniform.
     Quote "not a penny of public money will be spent on school uniform"
- Consideration of Sale of Business to Stevenson's or Monkhouse 04 December 2023
  - Stevenson's indicated that they were not interested as our margins were 20-30% too small and overheads too high. New contracts with schools would be needed to be put in place – Quick indication that no interest to them. Stevenson's offer an online only UK dispatched service
  - Monkhouse would need Contracts in place and model contract sent on Monday 10<sup>th</sup>
     December, forwarded to CYPES and they have indicated that they would not grant permission for schools to enter into the contract.

The current Monkhouse model is an online only UK dispatch service, however, they might consider a local operating model. CYPES stated that they would not sign up to the Monkhouse Contracts.
